Pelagic surveys require a definition of the vertical dimension 126

Size matters when choosing the proper gear and method for pelagic surveys 129

CENSUS METHODS FOR VIRUSES, BACTERIA, AND SMALL PHYTOPLANKTON 131

Virio- and bacterioplankton census methods require specialized equipment 132

Small (<10 μm) phytoplankton are most effectively collected by bottle 133

Seine nets can be easily deployed in shallow water by boat or by hand 148

Trawl nets are used in deeper waters and require the use of a vessel 149

Dredges must be pulled along the bottom to collect benthic organisms 150

Cast and push netting are best suited for use in bays, tidal creeks, and other small coastal areas 150

Gill netting is used to collect specimens from vast open-water areas, over extended periods of time 151

Trapping allows the collection of specimens that are unharmed during their capture 151

Hook and line methods are typically more selective than gill netting 151

How to define "effort" within CPUE analyses, based on the capture method 152

Univariate comparisons must be structured to possess only one scaled variable 159

COMMON STATISTICAL METHODS FOR UNIVARIATE ANALYSIS 162

The most common statistical tool for univariate analysis is the *t* test 163

The appropriate use of the *t* test depends on three critical assumptions 165

The single-sample *t* test is used to compare measurements against a historical or theoretical value 166

The paired-sample *t* test is used to test the dependence between two populations 166

Variance is used to determine whether to use the pooled-sample or welch's *t* test 167

The pooled-sample *t* test assumes equal variances between the populations being compared 168

Welch's *t* test is used when the variances of two populations are not equal 169

The one-way analysis of variance (ANOVA) is used to compare multiple populations simultaneously 169

COMMUNITY COMPARISONS USING UNIVARIATE ANALYSIS 171

Measures of species richness are the easiest way to compare communities 171

Simple community comparisons can be performed using ranked abundance data and the DAFOR/SACFOR methods 172

Biodiversity and its related measures are the cornerstones of community comparison methods 173

**PUTTING IT ALL TOGETHER 264**  
**TYPICAL HYDRODYNAMIC MODEL ELEMENTS 266**  
 Hydrodynamic models are solved by defining the forces at work within the spatial and temporal domain of fluid motion 266  
 The unequal distribution of mass, as it relates to water density, creates pressure-gradient forces that influence water movement 268  
 Frictional forces in the ocean play a significant role in water movement 269  
 The influence of tides is as varied as it is powerful 269  
**TYPICAL BIOGEOCHEMICAL MODEL ELEMENTS 270**  
 The fundamentals of chemistry are the backbone of biogeochemical models 270  
 Inorganic chemicals define the chemical nature of seawater, divorced from biology 270  
 Organic chemicals in seawater are the calling cards of life 271  
 Bacteria provide a fundamental link between the organic and inorganic chemistry of the sea 272  
 Diagenesis represents the fusion of geology and chemistry 273  
**TYPICAL RADIATIVE MODEL ELEMENTS 273**  
 Light and heat must penetrate the atmosphere before they reach the ocean 273  
 The radiation reaching the ocean surface is quickly attenuated as it travels through the water 275  
**TYPICAL ECOLOGICAL MODEL ELEMENTS 277**  
 Growth ( $\partial g$ ) describes the positive increment of biomass either from production among autotrophs or assimilation among heterotrophs 277  
 Diffusive and advective transport ( $\partial X$ ) move biomass throughout the domain in the horizontal dimension 278  
 Vertical migration and sinking ( $\partial Z$ ) move biomass throughout the domain in the vertical dimension 278  
 Reproduction ( $\partial Y$ ) represents the fraction of growth that is invested in the next generation 278  
 Respiration ( $\partial R$ ) is the loss of biomass attributed to gaseous wastes 278  
 Excretion ( $\partial E$ ) is the loss of biomass attributed to liquid wastes 279  
 Egestion ( $\partial F$ ) is the loss of biomass attributed to solid wastes 279  
 Mortality ( $\partial M$ ) is always represented as a loss of biomass, but it comes in many forms 279
